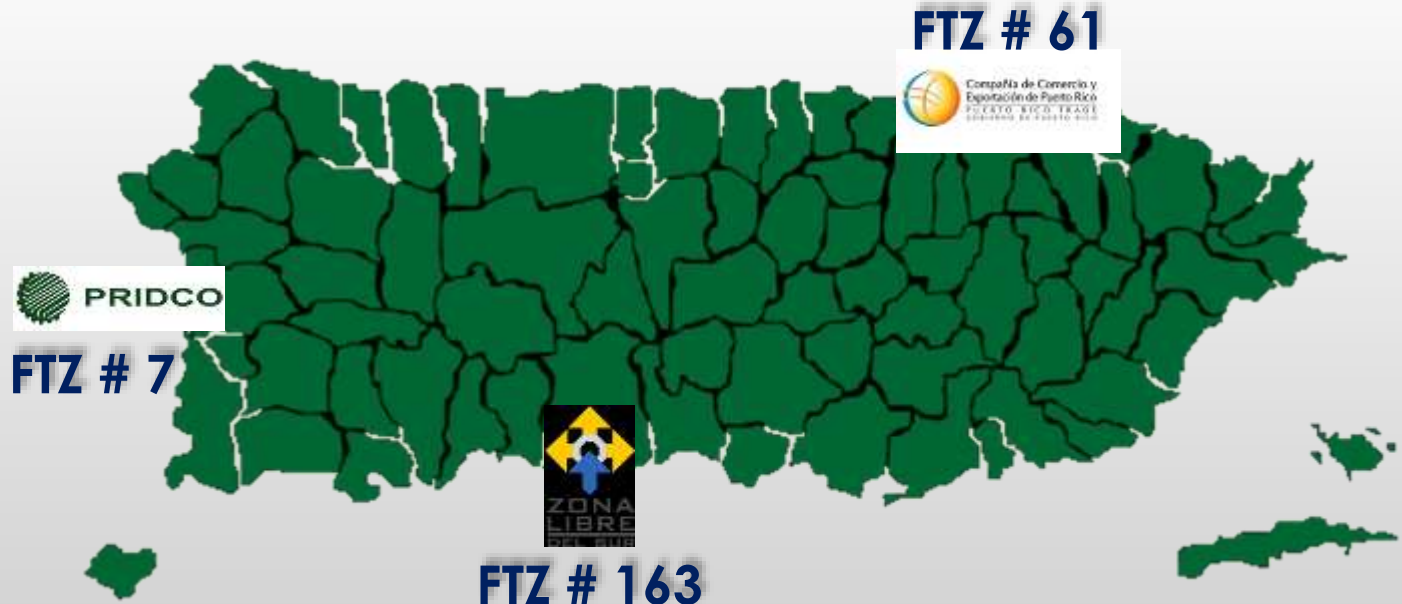


FTZ'S IN PUERTO RICO

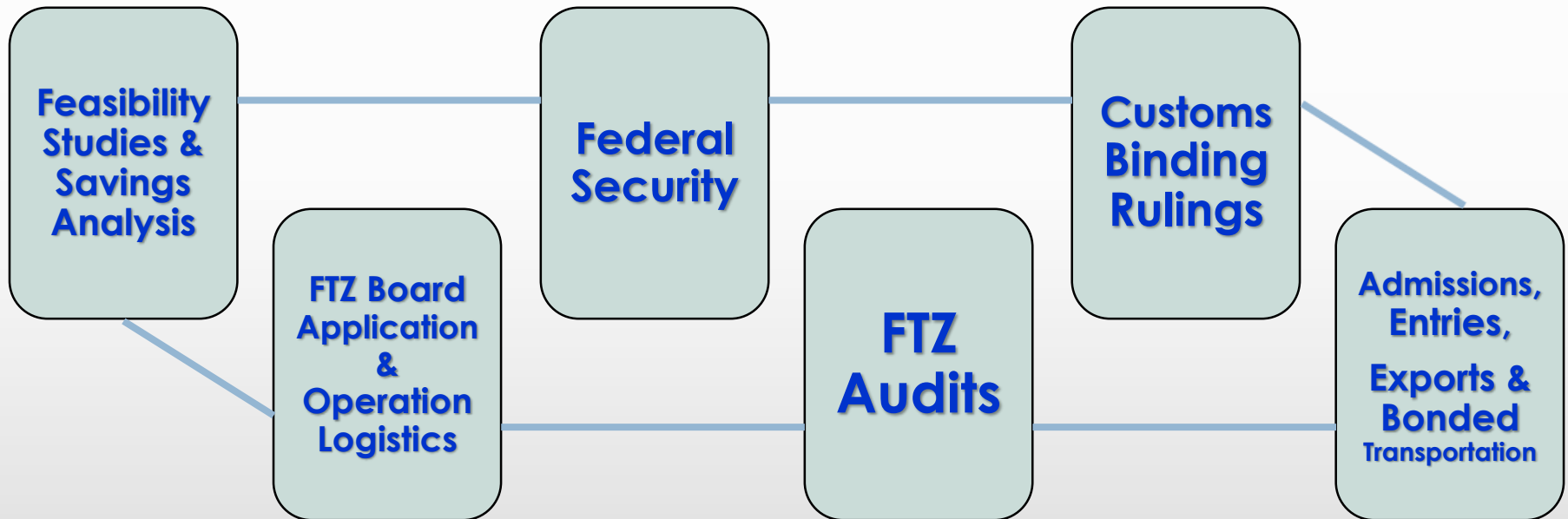

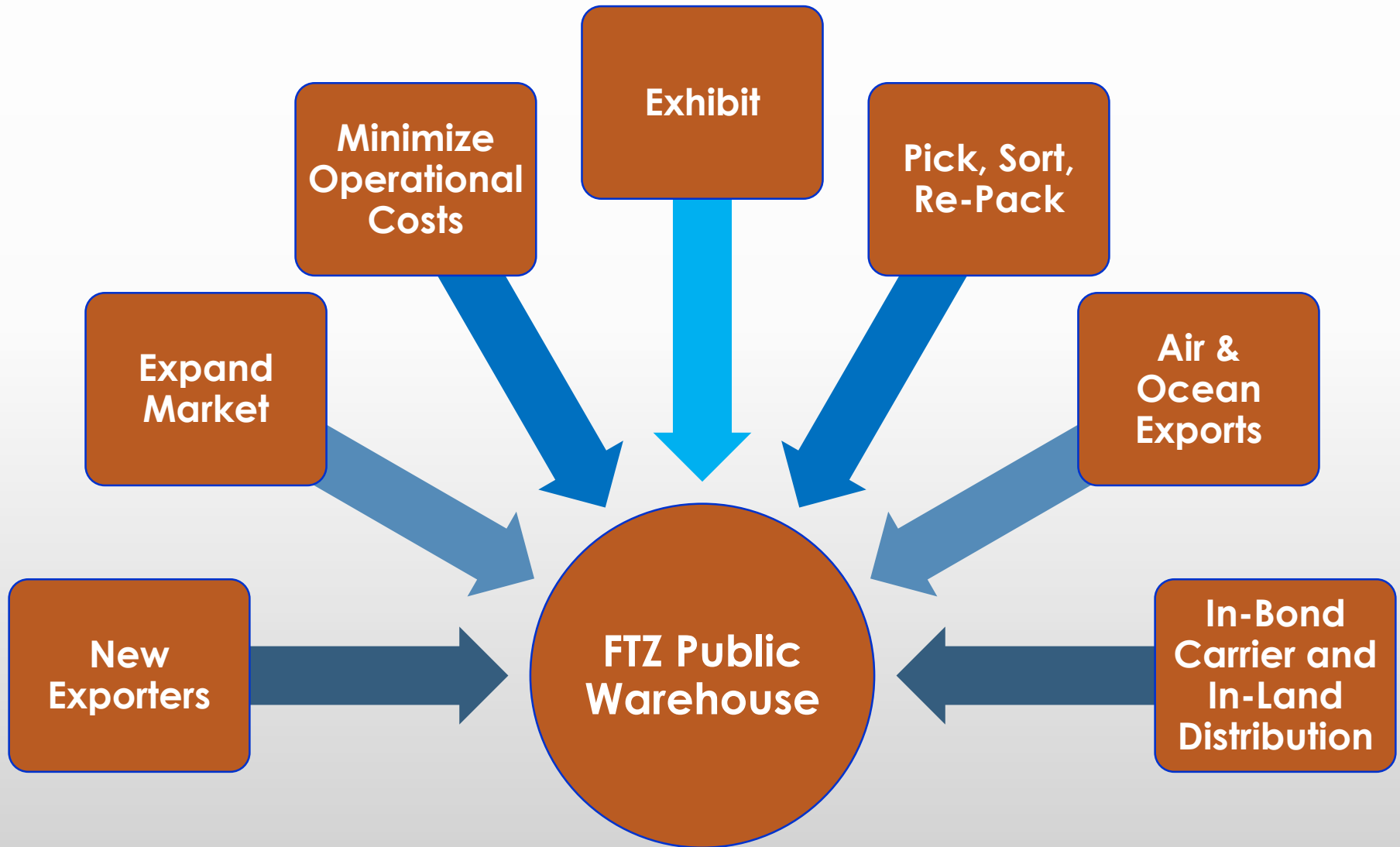
